

10th Forum for the Future of Agriculture: Time for solutions

Press release

Brussels – Tuesday, March 28th, 2017: The 10th annual Forum for the Future of Agriculture (FFA2017), being held today in Brussels, called upon all stakeholders committed to sustainable agriculture and protection of the environment, to move beyond pledges and take action in order to implement the United Nation's Sustainable Development Goals (SDGs). Along with the COP21 Paris Climate Agreements, these two international agreements provide a clear roadmap for sustainability in the years ahead. However, implementation remains key.

For this reason, FFA2017 today (with more than 1,700 participants) extended a broad-based call to action to businesses, politicians, farmers and civil society. A call to focus on the practical issues of implementation; a call for leadership from all stakeholder groups, including a commitment to cooperation and collaboration, which will deliver comprehensive benefits throughout the value chain, from the farm to the dinner table.

As uncertainty increases over the impact of climate change, low prices for farmers and the severe decline in biodiversity, it is not time for 'business-as-usual'. Agriculture continues to play a vital role if we are to provide for future generations, and should undergo systemic changes if we are to achieve the SDGs. Our ambitious agenda and goals were driven by our speakers and participants at FFA2017, who indicatively noted:

"If we want to achieve the Sustainable Development Goals, the time for solutions is now. There is no time and no need to wait for others to move. At the FFA, we aim to inspire the leadership and on the ground changes that are needed."
